As hosts of the 2026 FIFA World Cup, Canada, Mexico and USA will not enter the qualification.

The remaining 32 FIFA affiliated teams will qualify for three direct slots and two inter-confederation play-off slots in the final tournament.

Based on the FIFA rankings of November 2023, the top 28 teams will receive a bye to the second round, while the lowest four teams will enter the first round.

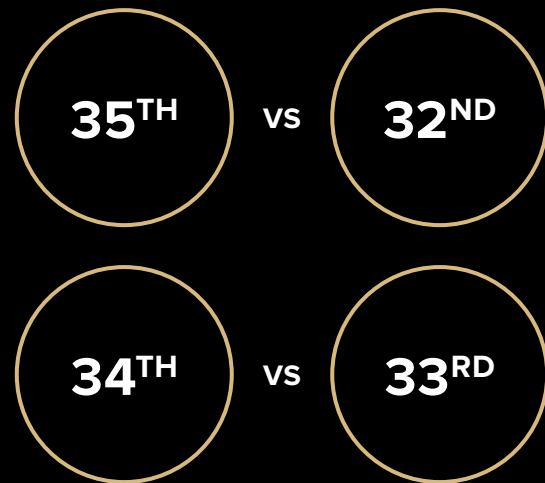

Format

First Round



- ▶ 2 home and away series among the last 4 Concacaf Teams.*
- ▶ 2 winners will progress to second round.
- ▶ Playoff 1 (35th vs. 32nd) Turks and Caicos Islands vs. Anguilla
- ▶ Playoff 2 (34th vs. 33rd) British Virgin Islands vs. US Virgin Islands

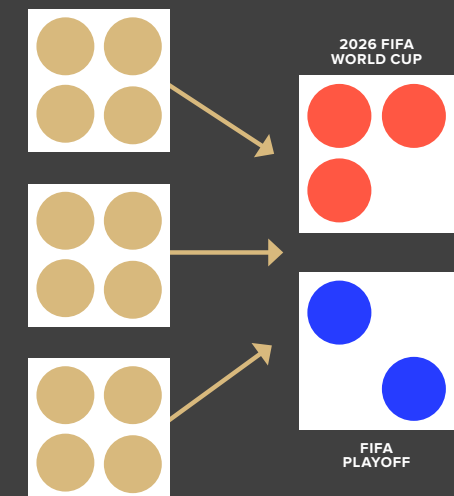

Second Round



- ▶ 6 groups of 5 teams (including teams from Round 1).
- ▶ 2 home and 2 away matches.
- ▶ 2 top teams of each group will advance to the Final Round.

Second Round



- ▶ 3 groups of 4 teams.
- ▶ 3 home and 3 away matches.
- ▶ 3 group winners will qualify directly to the 2026 FIFA World Cup, joining Canada, Mexico and United States.
- ▶ 2 best second place finishers will qualify to the FIFA World Cup Intercontinental Playoff.
